 To confirm the cash held on balance sheet for known accounts. Lower risk or longstanding clients with no change in securities and personal guarantees from prior years.

Confirmation of cash balances at any date in the year and post year-end as part of your going concern review.

Security & Compliance at the Core



Encryption & Audit Trail

All data in transit is protected using TLS (Transport Layer Security) and the Circit application can only be accessed over HTTPs.

All data at rest utilises 256-bit AES encryption of data using keys stored within the Azure Key Vault which makes use of Hardware Security Modules (HSMs) to safeguard the cryptographic keys and prevent tampering. Documents created by the Circit application include a comprehensive and immutable audit trail between all parties that includes a timestamp, IP address and end-user information. This ensures that documents cannot be tampered with and are permissible in court.

Infrastructure and Backups

Circit uses multiple data centres with reliable power sources and backup systems with 99.9% SLAs and geo-redundancy. Physical servers are located in Dublin, Ireland and failover servers are located in the Netherlands. A full backup of the system is taken every night with transaction log backups taken every fifteen minutes.

Circit is a registered Account Information Service Provider (AISP) under the European Union (Payment Services) Regulations 2018 [S.I. No. 6 of 2018]. Central Bank of Ireland Code - C176625
